

69 Explosive Ordnance Items Found and Moved to temporary Storage by National Safety Authority (NSA) operators

2120 UXOs have been found so far in 2018 by the Military Engineers and the NSA





Participated in a joint mission to Benghazi, along with OCHA and WFP. The delegation met with local authorities and the Commission for Mine Action (MA) of the HoR to discuss Mine Action issues in the East. The delegation also visited the areas most affected by the fighting, and attended a civil society meeting on MA organized by the Commission of Civil Society.

UNMAS Libya:

- Participated in field visits, attended several meetings in preparation of the liquid fuel disposal project and provided technical support to United Nations Guard Unit (UNGU) and UNSMIL.
- Participated in the OCHA-UNMAS-UNSMIL joint visit to Misrata/Tawergha. The Delegation met with Misrata Municipality, Tawergha Local Council and Dialogue Committee to discuss clearance activities in Tawergha and the safe return of IDPs to the city. LibMAC (Libyan Mine Action Centre) and Free Fields Foundation (3F) were in attendance.
- Programme review took place through WebEx with Chief of Programmes, Planning and Management Section, Paul Heslop, UNMAS team from Tunis, Libya and HQ and UNOPS PSC.
- Facilitated the LibMAC Director's meeting with implementing partners, which took place in Tunis to discuss and coordinate Humanitarian Mine Action activities, priorities and challenges.
- Ops team met with Global Clearance Solutions (GCS) regarding the "destruction of ERW in Misrata" project funded by the French Government to coordinate ways forward in line with the RFP and signed the contract. GCS was introduced to the LibMAC to discuss the project and finalize the details regarding their registration.
- Ops team held a technical meeting on the "destruction of ERW in Misrata" with the local implementing partner 3F.
- Continued coordinating the international response to the threat of explosive hazards in Sirt.
- Continued supporting the Libyan Mine Action Centre (LibMAC) and its coordination with mine action implementing partners.
- The deadline for receiving the SALW project applications was 31st August with more than 95 applications received.
