

Minutes of the meeting of delegations of Batten Aljabal and Kabaw Municipalities

We, representatives of municipalities of Kabaw and Batten Aljabal (Teji), meeting on 27 – 28 November 2017 in Tunis, Tunisia, under the auspices of UNSMIL and UNDP within the framework of national reconciliation, and following amicable discussions, we came up with the following points:

Governing Principles for both Parties:

1. Both Municipal Councils of Kabaw and Batten Aljabal shall establish a committee of 7-9 members and shall grant them all the powers required to carry out their tasks.
2. Continued engagement in dialogue and talks within this framework hinges on the commitment to complete the coordination arrangements and obtain the required permits and approvals from the two municipalities and Ministry of Local Government. UNSMIL should communicate with the Ministry in this regard.
3. The conflict between the two sides is a purely internal affair. Neither party shall have the right to file lawsuits in this regard before any authority other than the Libyan judiciary.
4. Undertaking to respect neighborly relations and consolidate the concepts of national partnership and co-existence.
5. Stress the inviolability of personal rights, refrain from actions that prejudice those rights, and acknowledge the exclusive right of disposition to claim or waive those rights or any legal implications entailed in accordance with the legislations in force.
6. Both parties shall undertake to renounce violence and extremism and shall commit to refraining from using force to resolve their disputes.
7. Both parties shall commit to signing the final agreement provided that it is endorsed by 50 persons from each party and approved by the Municipal Council, Shura Council, and Council of Notables from each party. The agreement shall also be endorsed by the sponsors and some of the actors attending the signature.
8. The final agreement shall be documented in accordance with the legislations in force at the relevant authorities represented by the Municipal Council, Shura Council, Council of Notables, and security directorates in both municipalities.
9. Minutes of each round of talks shall be prepared, forwarded to both parties and submitted for signature. Those who refrain from or fail to sign, and reasons for this, shall be

documented. A copy of the minutes shall be handed out to any of the representatives of the two parties to the conflict.

Disputed Issues

The outstanding issues between the two parties to the conflict (Tiji and Kabaw) include:

1. The disputed land and boundaries.
2. Grievances (Redressing grievances)
 - a. The events of 2010 – 2011 and their consequences
 - b. The events of 6 November 2012 and their consequences.

Mechanisms

- Establish committees for the outstanding issues between the two parties to the conflict.
- Those committees shall be established within a period not exceeding one month from the date of this meeting.

Commitments

- Each party shall strive to deter any security violations on their respective sides in a manner that ensures non-recurrence of such violations.
